SNOHOMISH COUNTY LABOR PRESIDENT SPEAKS TO 44TH

Darrell Chapman, life-long Democrat and Vice-Chair of the 21st as well as President of the Snohomish County Labor Council, shared his enthusiasm and ideas with the 44th LD Democrats at our March meeting.

Darrell said the combined work of Labor and the Democratic Party defeated Joe Marine who was running for Representative in the 21st. Brian Sullivan's' win "made all the difference" in the House and gave us "movement instead of deadlock," he stated.

Darrell explained the worker to worker program used successfully by labor organizations. Identifying labor voters, one to one contact, identifying voter issues, and registering those who were pro-labor has helped defeat anti-labor propositions and candidates.

The vast majority of Labor votes are Democratic, and 73% of Labor absentee voters actually voted in the off-year election. Darrell encouraged doorbelling with talking and listening, not just dropping literature

Darrell called our Rep. John Lovick "one of the best in the State" and predicted a "Sen. Lovick" in the future. He also praised Poppy Hanson, "a tremendous worker in labor programs here."

Democrats need to talk about the basics, Darrell recommended. The Democratic Party is the one that supports decent jobs with good wages and health care. People are FOR these things! With campaign finance reform we will have to adjust to Labor workers instead of Labor money. "Get them involved and give them a job," he advised.

RETIRED TEACHER REFLECTS ON NOBLE PROFESSION BY BETTY HURTIG (44th member and retired teacher)

Last year the *Bank of America* ran a striking series of black and white TV commercials. In one of these, a beautiful young boy clad in a white smock says he wants to become a teacher. As throngs of people ascend a staircase leading to a brilliant light above, a voice asks: "But would you not rather become a doctor? It is a noble profession, and you could become wealthy." The boy answers as he looks down from a further distance up the stairs: "But if there are no teachers, who then will teach the doctors?"

Teaching is also a noble profession, but teachers will not become wealthy. They will be paid pensions by the state. Is it right that these pensions should be shaved and kept constant at the lowest possible levels which, in many cases, can reduce retired teachers to near penury?

Teachers need a share in pension governance! This sharing role in pension decision-making was once in place, but no longer.

Quoting directly from the Washington State School Retirees Assn. Bulletin *Legislative Insight*: "When the Teachers Retirement System was established in 1947, it had a governing Board of Trustees. The Board had representation of active and retired employees and had significant autonomy over the management of the TRS. In a series of amendments from 1975-82, the Legislature abolished the Board of Trustees. The Board's authority was distributed to the Department of Retirement Systems, State Investment Board, and the Legislature."

Of course this issue was brought before the legislature early in the current session under HB2917. Our own John Lovick was one of the bill's 13 sponsors. So we must ask then: "How did the matter of governance fare in Olympia?" The answer? It died.

HB2917 evolved into SHB3010 which created a Select Committee on Pension Policy which increased the involvement of Retirement System members. But alas, at midnight March 14th when the Senate was to reconsider and return the Bill to the House the next day for concurrence, a debate about transportation improvement pre-empted this action, time ran out, and the issue became a leftover for further consideration.

It is disheartening to find that of the 50 state retirement systems, 46 states have retired and/or active members as trustees, but Washington does not. In spite of all this, I believe there is room for optimism following this legislative session. The issue seems to have been taken seriously—no longer simply dismissed out-of-hand.

P.S. After having taught English at Everett's Cascade High School for 15 years, I retired in 1979. At that point my pension was about \$480 per month. In these intervening 23 years it has grown to \$580. (Editor's note: The State continues to "borrow" from the retirement fund by not fully matching current retirement contributions.)

REPRESENTATIVE LOVICK REPORTS FROM OLYMPIA

Dear Friends:

My thanks to those of you who sent encouraging messages during the final, hectic weeks of session. I'm sorry I wasn't able to make the precinct caucuses on March 5th, but legislative business kept me tied to my desk in Olympia.

Legislators had to make a number of tough, unpopular choices this year. We were faced with a \$1.6 billion shortfall, but managed to pass a budget within the regular, 60-day session. We did our very best to protect the state's most vulnerable citizens and to keep our public schools strong. And we did it without raising general taxes.

Legislators also worked hard to bring relief to our congested highways. Two proposals were passed: one to address statewide transportation problems, and another designed to bring improvements to the Puget Sound region.

The statewide transportation package proposes to raise the gas tax 9 cents per gallon. It will be placed on the November ballot for voter approval. If passed it would provide:

\$5.6 billion for road projects;

\$330 million to city and county road programs;

\$681 million to the ferry system for new vessels, terminal improvements and passenger-only boats;

\$294 million for rail programs;

\$820 million for various public transportation projects, including \$450 million in direct distribution to transit systems.

The regional package will allow Puget Sound voters to raise their own taxes and levy tolls for highway improvement projects in our area. With voter approval, King, Pierce and Snohomish counties could collect up to \$8.7 billion in new taxes and fees, including an annual vehicle registration renewal fee of up to \$100 per car; a sales tax increase of up to 0.5 percent and \$1 highway tolls. The three county councils must craft the ballot proposal, which will likely be completed next year.

I'm back home in the 44th District now, and look forward to seeing more of all of you. As always, feel free to call me if you want to discuss the transportation packages or any other issue that interests you.
