**NOTICE OF APPEAL RIGHTS**

If you believe that you have a right to challenge this decision, you should know that Wisconsin statutes and administrative rules establish time periods within which requests to review Department decisions must be filed.

To request a contested case hearing pursuant to s. 285.81, Wis. Stats., you have 30 days after the decision is mailed, or otherwise served by the Department, to serve a petition for a contested case hearing on the Secretary of the Department of Natural Resources. Any such petition for hearing shall set forth the issues sought to be reviewed, the interest of the petitioner, the reasons why a hearing is warranted and the relief desired.

A person other than a permit holder or applicant may file a petition for a contested case hearing if the requirements of s. 285.81(2), Wis. Stats., are met.

For judicial review of a decision pursuant to ss. 227.52 and 227.53, Wis. Stats., you have 30 days after the decision is mailed, or otherwise served by the Department, to file your petition with the appropriate circuit court and serve the petition on the Department. Such a petition for judicial review shall name the Department of Natural Resources as the respondent.

**FINDINGS OF FACT, CONCLUSIONS OF LAW, AND DECISION**

**Findings of Fact**

The Department of Natural Resources (DNR) finds that:

- 1) Madison-Kipp Corp. is located at 2824 Atwood & 201 Waubesa, Madison, Dane County, Wisconsin.
- 2) DNR issued Madison-Kipp Corp. an air pollution control construction permit, No. 03-POY-328, on April 26, 2004, authorizing the modification of two reverberatory aluminum melt furnaces (RCI-1 and RCI 2). The permit was subsequently modified after a contested case hearing, pursuant to a decision issued by the Division of Hearings and Appeals in November, 2005.
- 3) Madison-Kipp Corp. submitted a request to DNR for revocation of air pollution control permit 03-POY-328 and additional information on January 23, 2006. Madison-Kipp no longer has a need for the increased emission levels or a change to the requirement for separation between charge of metal and chlorine addition. Madison-Kipp Corp. may continue to operate the furnaces in compliance with operation permit 113014220-P01.
- 4) DNR reviewed Madison-Kipp Corp.'s request and supporting materials and determined that the request to revoke the air pollution control permit is approvable. DNR received comments from the public on April 17, 2006. DNR reviewed the comments and considered them prior to making a final decision.
- 5) DNR has complied with the notification procedures set forth in s. NR 406.11, Wis. Adm. Code.
- 6) DNR has complied with the requirements of s. 1.11, Stats., and ch. NR 150, Wis. Adm. Code.

**Conclusions of Law**

DNR concludes that:

- 1) DNR has authority under s. 285.67, Wis. Stats., to promulgate rules containing criteria and procedures for revising, suspending, or revoking air pollution control permits. The rules for revoking construction permits are set forth in s. 406.11, Wis. Adm. Code.
- 2) DNR has authority under s. 285.67, Wis. Stats., and s. NR 406.11(1), Wis. Adm. Code, to revoke Madison-Kipp Corp.'s air pollution control construction permit upon the request of the permittee.

- 3) DNR is required to comply with s. 1.11, Stats., and ch. NR 150, Wis. Adm. Code, in conjunction with revoking an air pollution control permit.

**Decision**

DNR hereby revokes Madison-Kipp Corp.'s Air Pollution Control Permit, No. 03-POY-328, for modification of two reverberatory aluminum melt furnaces (RCI-1 and RCI 2).
